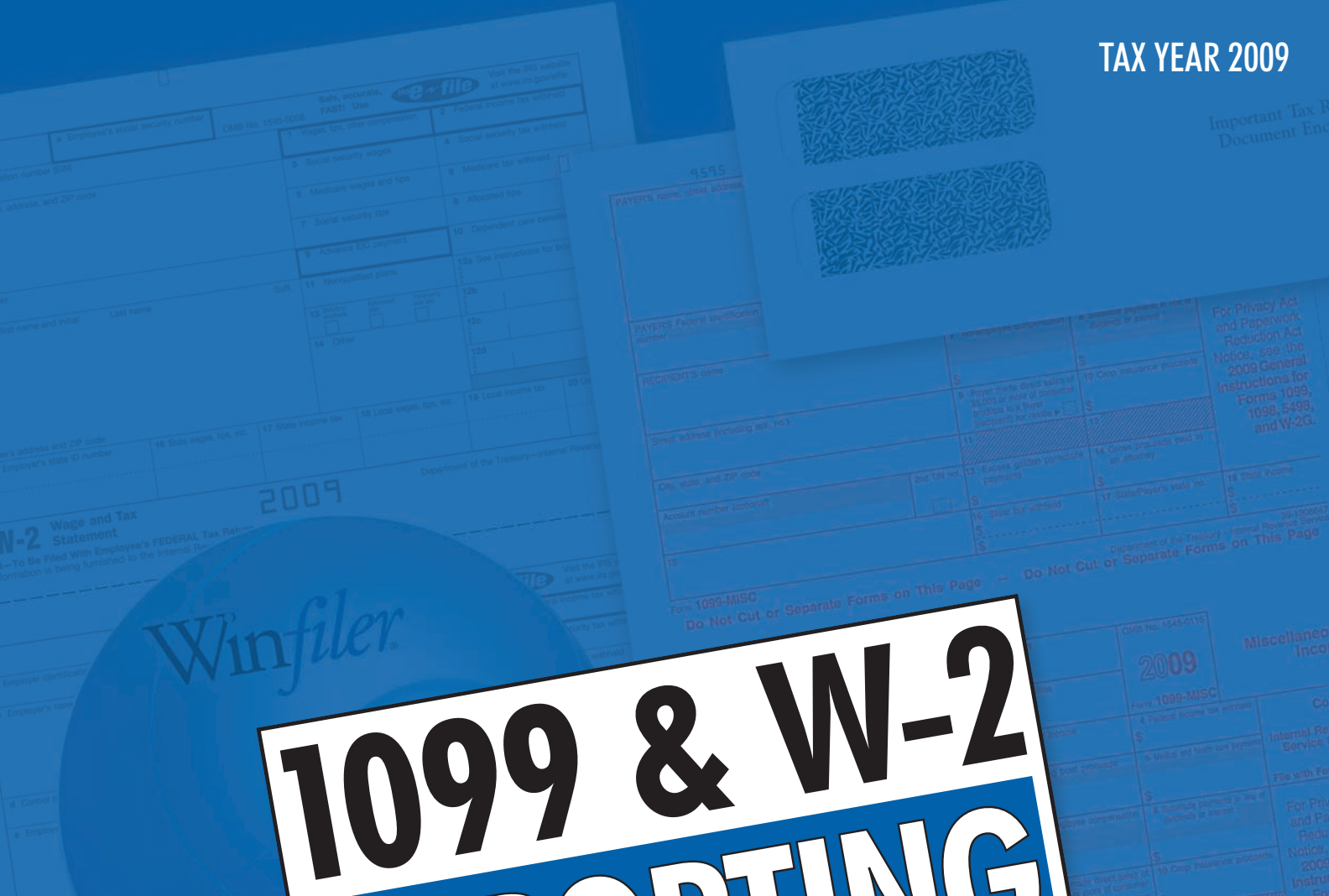

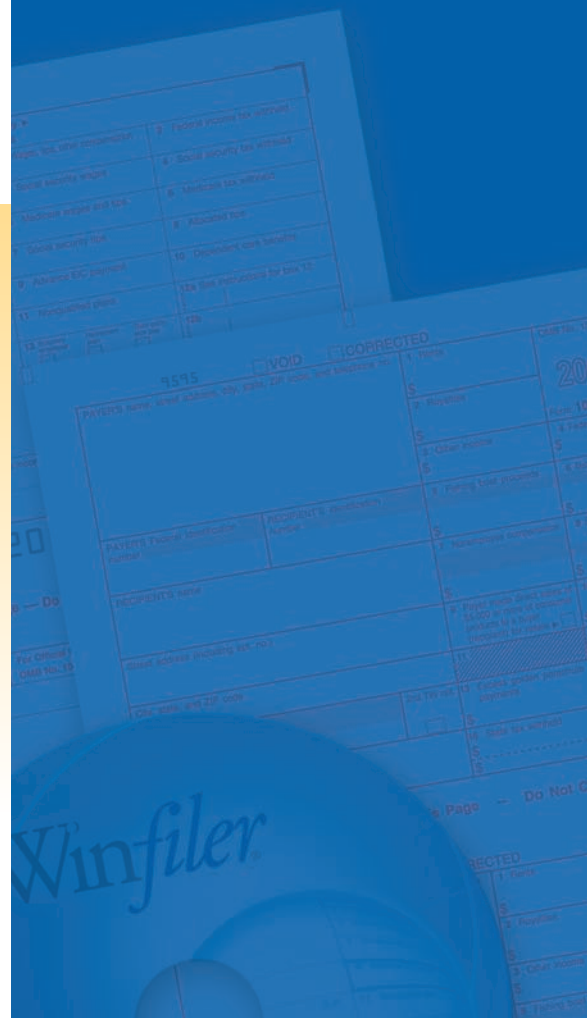

How many employees do you have?

Determines how many forms you need to order; order one form/set/kit for each employee, typically in increments of 25.

Which state(s) are you reporting to?

Determines how many parts you need and which forms you should order. See chart below for details.

Do you need to file a copy with a city or local tax agency?

If yes, order 8 part forms (double quantity of Copy 2 forms).

Are you filing for one company (EIN) or multiple?

If filing for one company, you need one W-3 form, which we include free with your order of W-2s. If filing for more than one company, order additional W-3 forms, one for each EIN.

How are you printing forms?

For laser and inkjet printers, use laser forms. For dot-matrix printers or typewriters, use continuous forms. If you process a larger volume of forms, consider using pressure seal to save time.

What type of software are you using?

Use the software compatibility chart on page 4 to determine the right forms, or request a free sample to test for data alignment.

Do you need blank or preprinted forms?

If your software prints only the employee data, use preprinted forms. If your software prints the employee data AND the form itself (boxes, etc.), use blank perforated laser paper.

How will you deliver forms to your employees?

Don't forget window envelopes made specifically for our forms for easy, secure mailing. For more efficient mailing, use self-seal envelopes.

Blank Forms

Use with software that prints the actual form (boxes, headers, etc.) AND employee data in one pass.

Preprinted Forms

Use with software that prints only the employee data.

Continuous Forms

Use with dot-matrix printers or typewriters.

Pressure Seal Forms

Ideal for easily printing and mailing a large volume of forms.

Envelopes

Secure delivery for all types of W-2 formats.

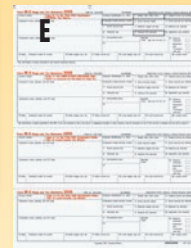

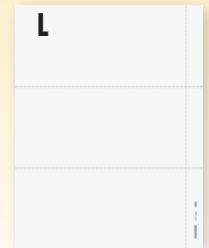

For laser and inkjet printers, use laser forms. For dot-matrix printer or typewriters, use continuous forms. If you process a larger volume of forms, consider using pressure seal to save time.

What type of software are you using?

Standard 1099 formats are compatible with most software programs. Standard formats are available for all 1099s. Non-standard formats (i.e., 4up) are available for 1099-MISC and 1099-R. Request a free sample to ensure compatibility with your software.

Do you need blank or preprinted forms?

If your software prints only the recipient data, use preprinted forms. If your software prints the recipient data AND the form itself (boxes, etc.), use blank perforated laser paper.
